



**MEMORANDUM OF UNDERSTANDING

College of pharmacy at Hawler Medical University and Awamedica drug manufacturer establish this memorandum of understanding (MOU) to foster mutual collaboration in higher education, scientific research and professional development training.

1. Both parties agree to encourage the following activities to promote mutual collaboration;
 - Awamedica will contribute in supply of materials for the purpose of education and research
 - Awamedica will contribute in conducting seminars and courses in the field of industrial pharmacy and pharmaceutical analytical chemistry
 - Joint researches
 - Exchange of research equipment and materials.
 - College of pharmacy's academic staff and postgraduate students will perform research utilizing Awamedica resources under supervision of both parties.
 - Visiting of undergraduate and postgraduate students for teaching purposes on regular base to Awamedica drug manufacturer under supervision of both parties.
 - During training or teaching tenure, students or visiting person shall abide the rules and regulations (GMP rules or organization policy) of the both parties.

Before these activities can be implemented, both parties shall discuss the issues involved to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the relationship.

2. This MOU is not considered to be a contract creating legal or financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange process and research relationship.
3. This MOU shall become effective for **five years** as of the date it is fully executed by both parties. The MOU may be amended by the written consent of the parties. The MOU may be terminated by either party with a minimum of 90 days written notice. If feasible, activities in progress at the time of termination of this MOU shall be permitted to conclude as planned unless otherwise agrees

4. This MOU should be reviewed at the end of the period to evaluate the progress and quality of the mutual cooperation. The MOU may be extended for additional periods upon consent of the parties.


